Principal activities and business review

BOS (Shared Appreciation Mortgages (Scotland)) Limited ("the Company") is a limited company incorporated and domiciled in England and Wales (registered no: 03281120).

The Company is not currently trading but holds an interest bearing bank account with Bank of Scotland plc ("BOS"), its immediate parent undertaking. However due to low interest rates for the current and previous year, there has been no interest earned on the funds held in the bank account. This account will earn interest in the future when interest rates rise to an appropriate level.

The Company is a subsidiary undertaking of BOS and ultimately Lloyds Banking Group plc ("the Group").

During the year ended 31 December 2019 the Company did not trade or incur any liabilities and consequently has made neither profit nor loss.

Directors' indemnities

4. Related party transactions

Bank of Scotland plc is the parent undertaking of the smallest such group of undertakings.
