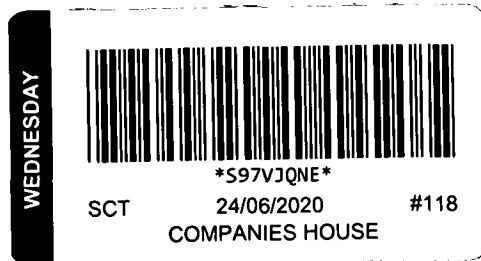

## Directors' report

For the year ended 31 December 2019

### Principal activities and business review

BOS (Shared Appreciation Mortgages (Scotland) No.2) Limited ("the Company") is a limited company incorporated and domiciled in England and Wales (registered no: 03331868).

The Company is not currently trading but holds an interest bearing bank account with Bank of Scotland plc ("BOS"), its immediate parent undertaking. However due to low interest rates for the current and previous year, there has been no interest earned on the funds held in the bank account. This account will earn interest in the future when interest rates rise to an appropriate level.

The Company is a subsidiary undertaking of BOS and ultimately Lloyds Banking Group plc ("the Group").

### Directors' indemnities

Lloyds Banking Group plc ("the Group") has granted to the directors of the Company a deed of indemnity through deed poll which constituted 'qualifying third party indemnity provisions' for the purposes of the Companies Act 2006. The deed was in force during the whole of the financial year and at the date of approval of the financial statements or from the date of appointment in respect of directors who join the board of the Company during the financial year. Directors no longer in office but who served on the board of the Company at any time in the financial year have the benefit of this contract of indemnity during that period of service. The indemnity remains in force for the duration of the directors' periods of office. The deed indemnifies the directors to the maximum extent permitted by law. Deeds for existing directors are available for inspection at the registered office of Lloyds Banking Group plc. In addition, the Group has in place appropriate directors and officers liability insurance cover which was in place throughout the financial year.

### 3. Related party transactions

The Company's immediate parent company is Bank of Scotland plc (incorporated in Scotland). The company regarded by the directors as the ultimate parent company is Lloyds Banking Group plc (incorporated in Scotland), which is also the parent undertaking of the largest group of undertakings for which group financial statements are drawn up and of which the Company is a member. Bank of Scotland plc is the parent undertaking of the smallest such group of undertakings. The Company holds a bank account with Bank of Scotland plc, its immediate parent company, but currently receives no interest thereon.

There were no transactions between the Company and key management personnel during the current or preceding year.

Key management personnel are employed by other companies in the Lloyds Banking Group and consider that their services to the Company are incidental to their other activities within the Group.
