# STRATEGIC REPORT

The Directors present their Strategic report for European Principal Assets Limited (the "Company") for the year ended 31 December 2019.

### PRINCIPAL ACTIVITY

The principal activity of the Company is to engage in financing transactions with other Morgan Stanley Group undertakings, with no significant changes expected in 2020.

The principal activity of the Company was previously the management of residential mortgage-backed debt, however, in December 2016, the Company disposed of its loan notes to a third party and in January 2017 it disposed of its remaining held for trading assets.

The Company's ultimate parent undertaking and controlling entity is Morgan Stanley, which, together with the Company and Morgan Stanley's other subsidiary undertakings, form the "Morgan Stanley Group". The Company's immediate parent undertaking is Morgan Stanley International Holdings Inc.

### **BUSINESS REVIEW**

### **Emergence of COVID-19**

The coronavirus disease (COVID-19) pandemic has, and will likely continue to, severely impact global economic conditions, resulting in substantial volatility in the global financial markets and operational challenges. The extent of the impact is highly uncertain and cannot be predicted and could adversely affect the future operations and financial condition of Morgan Stanley and the Company.

# Overview of 2019 performance and key performance indicators

The company's main key performance indicators are loss after tax, total assets and total liabilities.

The Company made a loss after tax for the financial year of €98,000 compared to a loss after tax of €528,000 in the prior year. Losses are primarily due to interest expense on a loan borrowing from another Morgan Stanley Group undertaking, which increased in the current and prior year due to higher average proxy rates in 2018.

The loss in the current and prior year is primarily due to a United State Dollar ("USD") loan payable of approximately €6,500,000 with the Company's immediate parent undertaking which generated average annual interest at 3.78% (2018: 3.57%). This is offset by a Euro ("EUR") loan receivable of approximately €6,700,000 with the Company's immediate parent undertaking which generated average annual interest at 0.95% (2018: 1.06%). During June 2019 non-interest bearing loans with other Morgan Stanley Group were repaid and the proceeds used to reduce both the USD and EUR to €467,000 and €1,989,000 respectively.

The Company's total assets at 31 December 2019 were €2,011,000 (2018: €2,098,000). Total liabilities at 31 December 2019 were €12,000 (2018: €1,000). The movement in assets primarily relates to a decrease in cash and short term deposits. Liabilities have increased primarily due to the audit fee being paid by another Morgan Stanley Group undertaking.

On 12 December 2018, Capital contribution reserve increased by €33m to €392m following a further contribution from the Company's immediate parent undertaking, Morgan Stanley International Holdings Inc. There were no capital contributions in 2019.

The Company settled its intercompany borrowings following receipt of the capital contribution.

# Risk management

The Directors consider that the Company's key financial risks are credit risk, primarily its concentration of exposure to other Morgan Stanley Group undertakings and liquidity risk arising primarily through its exposure to other Morgan Stanley Group undertakings presented within other receivables and payables, loans and advances and debt and other borrowings. The Company leverages the Morgan Stanley Group's credit and liquidity risk frameworks to identify measure, monitor and control credit risk and to ensure that the Company has access to adequate funding.

The Company also has some limited exposure to market, operational and legal, regulatory and compliance risks.

The Company leverages the risk management policies and procedures of Morgan Stanley Group.

### Going concern

Business risks associated with the uncertain market and economic conditions are being actively monitored and managed by the Morgan Stanley Group and Company. Retaining sufficient capital and liquidity to withstand these market pressures remains central to the Morgan Stanley Group and Company's strategy. The existing and potential effects of COVID-19 (coronavirus) on the business of the Morgan Stanley Group and Company have been considered as part of the going concern analysis, including impact on operational capacity, access to liquidity and capital, contractual obligations. The Company has access to further Morgan Stanley Group capital and liquidity as required.

Taking the above factors into consideration, the Directors believe it is reasonable to assume that the Company will have access to adequate resources to continue in operational existence for the foreseeable future. Accordingly, they continue to adopt the going concern basis in preparing the annual report and financial statements.

# Section 172(1) statement

The Directors are aware of their responsibilities to promote the success of the Company in accordance with s172 of the Companies Act 2006. When making decisions, Directors have regard to the interests of stakeholders relevant to the Company as well as the need to maintain a reputation for high standards of business conduct and the long term consequences of decisions. # NOTES TO THE FINANCIAL STATEMENTS Year ended 31 December 2019

### 1. CORPORATE INFORMATION

The Company is incorporated and domiciled in England and Wales, United Kingdom, at the following registered address: 20 Bank Street, Canary Wharf, London, E14 4AD United Kingdom. The Company is a private company and is limited by shares. The registered number of the Company is 05758075.

The Company's immediate parent undertaking is Morgan Stanley International Holdings Inc., which has its registered office c/o The Corporation Trust Company, Corporation Trust Center, 1209 Orange Street, Wilmington, DE 19801, United States of America and is incorporated in the state of Delaware, in the United States of America.

The Company's ultimate parent undertaking and controlling entity and the largest and smallest group of which the Company is a member and for which group financial statements are prepared is Morgan Stanley which, together with the Company and Morgan Stanley's other subsidiary undertakings, form the Morgan Stanley Group. Morgan Stanley has its registered office c/o The Corporation Trust Company, Corporation Trust Center, 1209 Orange Street, Wilmington, DE 19801, United States of America and is incorporated in the state of Delaware, in the United States of America. Copies of its financial statements can be obtained from www.morganstanley.com/investorrelations.

# 2. BASIS OF PREPARATION

### Statement of compliance

These financial statement are prepared on a going concern basis as explained in the Strategic Report and under the historical cost convention in accordance with UK Generally Accepted Accounting Practice (UK Accounting Standards and applicable law), including FRS 101.

The Company has taken advantage of the disclosure exemptions available under FRS 101 in relation to fair value measurement, presentation of a cash-flow statement, accounting standards not yet effective and related party transactions.

Where relevant, equivalent disclosures have been provided in the group accounts of Morgan Stanley, in which the Company is consolidated. Copies of Morgan Stanley's accounts can be obtained as detailed at note 1.

# New standards and interpretations adopted during the year

The following standards and amendments to standards relevant to the Company's operations were adopted during the year. Except where otherwise stated, these standards and amendments to standards did not have a material impact on the Company's financial statements.

As part of the 2015-2017 Annual Improvements Cycle published in December 2017, the International Accounting Standards Board ("IASB") made amendments to IAS 12 'Income Taxes' for application in accounting periods beginning on or after 1 January 2019. The amendments were endorsed by the European Union ("EU") in March 2019. International Financial Reporting Interpretations Committee 23 ("IFRIC 23") 'Uncertainty over Income Tax Treatments' was issued by the IASB in June 2017 for application in accounting periods beginning on or after 1 January 2019. The interpretation was endorsed by the EU in March 2019.

# Critical judgements in applying the Company's accounting policies

No judgements have been made in the process of applying the Company's accounting policies that have had a significant effect on the amounts recognised in the financial statements. The Company has not made any key assumptions and there are no other key sources of estimation uncertainty in the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities in the next financial year.

# 2. BASIS OF PREPARATION (CONTINUED)

### The going concern assumption

The Company's business activities, together with the factors likely to affect its future development, performance and position, are reflected in the Business Review section of the Strategic report on pages 1 and 2.

As set out in the Strategic report, retaining sufficient liquidity and capital to withstand market pressures remain central to the Morgan Stanley Group's and the Company's strategy.

Taking the above factors into consideration, the Directors believe it is reasonable to assume that the Company will have access to adequate resources to continue in operational existence for the foreseeable future. Accordingly, they continue to adopt the going concern basis in preparing the annual report and financial statements.

# 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### a. Functional currency

Items included in the financial statements are measured and presented in Euro, the currency of the primary economic environment in which the Company operates.

All currency amounts in the financial statements and Strategic and Directors' reports are rounded to the nearest thousand Euro.

### b. Foreign currencies

All monetary assets and liabilities denominated in currencies other than Euro are translated into Euro at the rates ruling at the reporting date. Transactions are denominated in currencies other than Euro are recorded at the rates prevailing at the dates of the transactions. All translation differences are recognised through the statement of comprehensive income.

# c. Impairment of financial instruments

The Company recognises loss allowances for expected credit losses ("ECL") for its financial assets classified at amortised cost. ECLs are the present value of cash shortfalls over the expected life of the financial instrument, discounted at the asset's EIR. ECL are recognised in the statement of comprehensive income within 'Net impairment loss on financial instruments' and is reflected against the carrying amount of the impaired asset on the statement of financial position as an ECL allowance. Where there has been a reduction in ECL, this will be recognised within 'Net reversal of impairment loss on financial instruments.

# d. Cash and cash equivalents

Cash and cash equivalents comprise cash and demand deposits with banks with original maturities of three months or less, that are readily convertible to known amounts of cash and subject to insignificant risk of change in value.

# e. Income tax

The tax expense represents the sum of the tax currently payable and is calculated based on taxable profit for the year. Taxable profit may differ from profit before taxation as reported in the statement of comprehensive income because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Company's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the reporting date.
